On March 21, 2013, SAP AG, a stock corporation organized under the laws of the Federal Republic of Germany ("SAP"), issued a press release (the "Press Release") announcing that the Supervisory Board of SAP has decided to follow the recommendation of the Executive Board to propose at the Annual General Meeting of Shareholders a dividend of 0.85 per share for the fiscal year 2012.
