- (1) The sale of shares by the reporting person to satisfy the reporting person's obligations with respect to withholding taxes in connection with the vesting on November 4, 2018 of 12,919 restricted stock units held by the reporting person.
- (2) An initial grant of 155,000 restricted stock units (RSUs) was received on November 4, 2015 and reported on Form 4 dated November 6, 2015.
