(1) Represents the difference between 32,786 performance-based shares of Restricted Common Stock that vested on February 23, 2009 and 24,200 performance-based shares of Restricted Common Stock whose grant was originally reported on a Form 4 filed with the U.S. Securities and Exchange Commission on February 27, 2006 (the "Original Form 4"). As reported on the Original Form 4, such performance-based shares were originally granted to the Reporting Person on February 23, 2006 under the 2004 Stock-Based Incentive Compensation Plan and were to vest on February 23, 2009 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 24,200.

(2) Represents shares transferred to the Company for tax withholding in connection with the vesting of the performance-based vested shares of Restricted Common Stock as well as the vesting of 15,313 shares of Restricted Common Stock originally granted on February 23, 2006.
