- (1) On March 14, 2015, 90,000 performance-vesting restricted share units held by Mr. Durkin vested and, as allowed under the terms of his restricted share unit agreement, the Company withheld 46,962 shares otherwise deliverable to him to satisfy the resulting tax withholding obligations.
- (2) On March 14, 2015, 87,500 restricted share units held by Mr. Durkin vested and, as allowed under the terms of his restricted share unit agreement, the Company withheld 43,101 shares otherwise deliverable to him to satisfy the resulting tax withholding obligations.
