Item 1.01 Entry into a Material Definitive Agreement.

On December 8, 2015, Western Gas Partners, LP ("WES") extended its commodity price swap agreements with Anadarko for the DJ Basin complex and Hugoton system from January 1, 2016, through December 31, 2016. Notional volumes for each of the commodity price swap agreements are not specifically defined. Instead, the agreements apply to the actual volume of natural gas, condensate and NGLs purchased and sold at the DJ Basin Complex and the Hugoton system. The prices set forth in the extended swaps are more favorable than prevailing market prices on the date the extended commodity price swap agreements were executed. There can be no assurance that these commodity price swap agreements will be renewed or extended beyond December 31, 2016, on similar terms or at all. The table below summarizes the swap prices compared to the forward market prices on the date the commodity price swap extensions were executed.
