Explanatory Note

On October 1, 2018, BOK Financial Corporation (the "Company") filed a Current Report on Form 8-K (the "Original Form 8-K") disclosing the completion of the previously announced merger with CoBiz Financial Inc., pursuant to the Agreement and Plan of Merger dated as of June 17, 2018 between CoBiz, the Company, and an Oklahoma corporation and wholly owned subsidiary of the Company, BOKF Merger Corporation Number Sixteen.

Under Item 9.01 of the Original Form 8-K, it stated that financial statements of business acquired and pro forma financial information would be filed by amendment no later than 71 days following the date the Original Form 8-K was required to be filed. Upon review of the financial information of the Company and CoBiz Financial Inc., we have determined no additional information is required to be filed or furnished.
