Item 1.01. Entry into a Material Definitive Agreement.

On February 24, 2012, First PacTrust Bancorp, Inc., a Maryland corporation (<u>"First PacTrust"</u>), Gateway Bancorp, a California corporation (<u>"Gateway"</u>), each of the stockholders of Gateway and the D & E Tarbell Trust, u/d/t dated February 19, 2002 (in its capacity as the Sellers' Representative) entered into Amendment No. 2 (the <u>"Amendment"</u>) to that certain Stock Purchase Agreement, dated as of June 3, 2011, as amended on November 28, 2011, among the parties (the <u>"Purchase Agreement"</u>).
