Each of the Reporting Persons disclaims beneficial ownership of the shares reported herein except to the extent of its or his pecuniary interest therein. Shares of Common Stock reported herein as of December 31, 2017, include (i) for the Fund, 729,089 shares of Common Stock and options to acquire an additional 20,756 shares of Common Stock, and (ii) for the Account, 145,911 shares of Common Stock and options to acquire an additional 4,244 shares of Common Stock.
