**Hsinchu, Taiwan, R.O.C. June 15, 2010** TSMC (NYSE: TSM) today held a shareholders meeting at which passed the following major resolutions:

1. Approved the 2009 Business Report and Financial Statements. Consolidated revenue for 2009 totaled NT\$295.74 billion and net income was NT\$89.22 billion, with earnings per share of NT\$3.44.
2. Approved the distribution of a NT\$3.0 cash dividend per common share.
3. Approved amendments to TSMC's Articles of Incorporation expanding the company's business scope to encompass solid-state lighting and solar power.
