The Trust Shares are paired with shares of Carnival Corporation Common Stock and are represented by the same stock certificate. - (3) The prices included on this form represent the sales price for the paired Trust Shares and shares of Carnival Corporation Common Stock.
- (4) The shares covered by this form were sold pursuant to a Rule 10b5-1(c) sales plan dated August 28, 2003.
